LIFETIME CERTIFICATION

General Instructions:

Lifetime certification as a Therapeutic Touch® Recognized Practitioner or Therapeutic Touch Recognized Teacher is open to all Therapeutic Touch Practitioners who have practiced Therapeutic Touch (Kreiger/Kuntz method) continuously for a minimum of 20 years.

Certification is intended for those Therapeutic Touch Practitioners who meet BCTTNS education and practice criteria for TTRP or TTRT and have maintained a BCTTNS membership (or maintained in another Canadian TT Network; International TT Network; or TT International Association Inc.) in good standing for a minimum of 10 consecutive years.

During Lifetime Certification, yearly membership fees will be required to be paid to BCTTNS. Check lists will no longer be required to be submitted.

Submission guidelines:

1. Complete the Application form for Lifetime Certification with BCTTNS for TTRP/TTRT.
2. Evidence of Practice Participation: provide a 1 – 2 page summary of your experience, related education and training, practice, and community involvement over the last 20 years. Include any of the following categories, as applicable:
 - the type and amount of your TT practice.
 - participation in or facilitation of a Practice Group.
 - volunteering.
 - mentorship, teaching, supervision of TT sessions.
 - community involvement.
 - how long have you been a BCTTNS member.
 - continuing TT studies or education.
 - what level of TT course has been completed.
 - participation in workshops, conferences, community events.
 - work on a TT committee.
 - writing TT articles.
3. Submit completed form and evidence of participation involvement information to Education Chairperson:

4. If applicable, submit annual membership renewal form with membership fee.

Review

The information received will be considered and evaluated based on completion of all requirements outlined in the BCTTNS curriculum and guidelines, continued practice, education and training. Certification approval is at the discretion of the Board of Directors.
